In the event the sponsor cancels all or part of the sponsorship contracted, the sponsor shall pay FFA a fee (the Cancellation Fee) equal to all monies due. Any Cancellation Fee is due at the time of cancellation. A payment to FFA under this contract shall be deemed fully earned and non-refundable.
